Investment debt means only those debts related to the investments.

Investments do not include the home you live in, the value of life insurance, retirement plans (pension funds, annuities, noneducation IRA's, Keogh plans, etc.) and prepaid tuition plans, cash, savings, and checking accounts already reported on Questions 43 and 81 on the FAFSA Form.
