The Virginia M. Hensley Education or Health Care Two-Year Transfer Scholarship recognizes outstanding academic and personal achievement, and is awarded to a graduating Kellogg Community College student transferring to one of the following Michigan Public Colleges or Universities, which offer baccalaureate degrees in Education or Health Care.

- Central Michigan University
- Eastern Michigan University
- Ferris State University
- Grand Valley State University
- Lake Superior State University
- Michigan State University
- Michigan Technological University
- Northern Michigan University
- Oakland University
- University of Michigan
- Wayne State University
- Western Michigan University

The recipient of the Hensley Transfer Scholarship will receive an award equal to the lesser of the annual tuition and fees of the year of the award in question at Western Michigan University or the actual annual tuition and fees for the year of the award in question at the university the recipient elects to attend. The scholarship will be awarded for two years, provided student maintains eligibility.

All scholarship applications are given equal consideration by a scholarship committee appointed by the KCC Foundation. The selection committee will review the applicant's academic records, school, community and service activities; and conduct personal interviews.

Criteria and Guidelines

- Applicant must be a citizen of the United States or eligible non-citizen.
- Applicant must graduate during the 2017-2018 academic year from Kellogg Community College, and transfer to a Michigan Public College or University which grants a baccalaureate in Education or a Health Care field and be a full time student.
- 3.5 cumulative GPA or higher.
- Demonstrate leadership experience, community and service activity and school involvement.
- Applicant must provide an acceptance letter from the college to which they will transfer.
- All awards will be sent directly to the baccalaureate degree granting institution.

Recipient Responsibilities

- Maintain 3.5 cumulative GPA or higher.
- Remain a full-time student fall and spring semesters.

Application Requirements

1. Submit a completed Virginia M. Hensley Education or Health Care Two-Year Transfer Scholarship application by March 23, 2018. Answer each question to the best of your ability.
 - Include a copy of your Student Aid Report, if you completed a FAFSA, or complete financial information section.
 - Include a copy of DD Form 214, if you are a military veteran.
2. Submit an essay of at least 150 words, but no more than two pages addressing all of the following:
 - Why you have chosen your field of study; what led you to this decision?
 - Future career goals; the profession or occupation you intend to enter.
 - Describe your leadership experience and what you learned from it.
 - Who influenced you the most while attending Kellogg Community College and why?
3. Attach a copy of your course history (unofficial KCC transcript).
4. Attach a copy of your acceptance letter to the baccalaureate degree-granting institution.
5. Attach a résumé of employment history, education, school and community service activities, and volunteer experiences.
6. Enclose two signed current letters of recommendation from professors, academic advisors, employers, and/or community members.
