

# 2019/2020 NURSING LPN TO RN ADVANCED PLACEMENT APPLICATION (Return to Admissions)

**Applications are accepted beginning August 1, 2018.**

**The deadline date to submit an application for the Nursing LPN to RN Advanced Placement program is January 15, 2019.**

The following items on this application must be completed and submitted prior to applying.

**IMPORTANT: Only complete applications will be accepted. Incomplete applications will not be considered.** Items already on file at KCC do not need to be re-submitted; however, these items must be noted on this application, where indicated. Complete all sections on this page and submit this application to the Admissions office. This is a separate application used for Nursing LPN to RN Advanced Placement applicants ONLY.

- 18 years of age at the start of nursing program.** (Clinical education partners may require students to be 18 years of age to participate in clinical learning experiences.)

  - List each college attended on the Selective Admission Application.
- Submit copy of current Michigan LPN licensure to Selective Admissions
- Submit Nursing LPN to RN Advanced Placement Application and writing assignment to Selective Admissions
